Dear President Biden, Secretary Mayorkas, and Secretary Blinken:

We, the undersigned 101 faith-based organizations and 151 faith leaders, write with grave concern about the escalating crisis in Haiti and to call for immediate humanitarian actions for Haiti. We call on you to: redesignate and extend Temporary Protected Status (TPS) and Special Student Relief, pause all deportations, and expand key lawful migration pathways. We also urge you to halt any plans to detain Haitian migrants at Guantanamo Bay. Many of our organizations and places of worship have deep connections to Haiti and continue to work with our partners there to prevent violence, promote peace and justice, and welcome Haitians displaced by the ongoing crisis. Our diverse faith traditions call us to express solidarity with all people whose lives are impacted by conflict and violence, and we urge the Administration to vigorously pursue all options for humanitarian protection for Haitians.

According to the United Nations, armed gangs have seized control of 80 percent of Haiti's capital, Port-au-Prince. In recognition of the deteriorating situation in Haiti, the U.S. military airlifted embassy staff from the country on March 10th. Today, the widespread violence has severely escalated, with coordinated gang attacks and prison breaks that forced Prime Minister Ariel Henry to agree to resign. This has disrupted government functions, closed Haiti's main airport, displaced over 160,000 civilians since February 2024, and triggered a devastating hunger crisis. Approximately half of the population, including nearly three million children, requires humanitarian aid. We are especially concerned about the reports of rape, indiscriminate kidnapping, and vigilante violence against the civilian population.

Mass migration from Haiti is closely tied to historical Western foreign interventions. The ramifications of this history and ongoing crisis continue to put the lives, rights, and freedoms of all Haitians at risk. The U.S. and the international community must act now to show the Haitian people that we stand with them. As Haitians pursue multiple avenues to end this turmoil and rebuild the government, the U.S. and the international community must also make clear that they support Haitians' self-determination.

We call on the Administration to:

Extend and redesignate TPS for Haiti and Special Student Relief for Haitian Students as soon as possible

The existing TPS designation for Haiti is set to expire on August 4, 2024. In addition to the currently deteriorating situation, all the conditions leading to the Biden administration's TPS extension and redesignations on December 5, 2022, and August 3, 2021 have worsened. The situation therefore meets the TPS designation criteria of temporary and extraordinary conditions that make a safe return to Haiti impossible. TPS designations can also promote stability,

because Haitians with work permits can send increased remittances to relatives in Haiti, helping them cover basic needs.

The Administration can also extend Special Student Relief employment benefits for nonimmigrant students from Haiti experiencing severe economic hardship. This notice is set to expire on August 3, 2024.

Halt plans to detain Haitian migrants interdicted at sea at Guantanamo Bay or detention centers in other countries

We are concerned by recent reports that the administration is considering detaining Haitians interdicted at sea at the Guantanamo Bay naval base and other offshore migrant detention centers. The period of detaining Haitian refugees at Guantanamo Bay is a shameful chapter in our nation's history. The history of Haitian refugees at Guantanamo Bay underscores the importance of treating all individuals with dignity and ensuring their rights are protected, especially in times of crisis. Haitians fleeing violence and persecution need support, not punishment. Instead of denying them protection by imprisoning them, we encourage the administration to take all available steps to restore and expand asylum processing at and between ports of entry, including for Haitians interdicted at sea, and to intervene in efforts by U.S. states to unjustly detain Haitian migrants.

Indefinitely halt deportations to Haiti, release detained Haitians, and support administrative closure of removal cases

The U.S. continues repatriations to Haiti, even though the Haitian government is unable to safely receive returnees. We ask the Biden administration to halt all removal flights and maritime removals to the already-overburdened country and urge favorable prosecutorial discretion for Haitians with final removal orders, which may include release from immigrant detention if they pose no threat to public safety. For individuals deemed to pose a security threat who cannot be returned to their home country due to the risk of harm, we urge the U.S. to explore alternatives that balance the need for security with the individual's right to non refoulement.

Expand and Expedite Parole to Haitians

We request that the administration raise the monthly cap on the Cuban-Haitian-Nicaraguan-Venezuelan (CHNV) parole process, and expedite the processing time. This program has created a key pathway for nationals of these countries to seek protection in the United States. This program not only facilitates family reunification and strengthens connections between communities, but it also helps mitigate the risk associated with perilous migration journeys that many Haitians now have no choice but to take in search of safety. By expanding and expediting these applications, the U.S. will be directly responding to the critical humanitarian challenges facing Haiti. We also request expedited processing for the Haitian Family Reunification Program.

Maintain Access to Asylum

While the CHNV parole program is an important humanitarian pathway, it should not be considered a substitute for the right to seek asylum. This is particularly true for asylum seekers from countries like Haiti, where civil society and infrastructure have collapsed. The main airport in Haiti is currently closed, creating a barrier to the CHNV parole program beneficiaries to leave the country. A robust asylum system is an essential protection for people fleeing violence who are unable to access flights or passports. We urge the Biden administration not to enact further

asylum restrictions and to consider ways to make the asylum system more accessible to Haitians.

Our faith traditions call on us to welcome the stranger and take action in solidarity with those fleeing violence, injustice, and disaster. In 2020, President Biden promised Haitian communities that he would "be there and stand with [them]," and it is important now, more than ever, to renew this promise. Guided by our shared faith principles, we must ensure that no Haitian is sent back to dangerous, unlivable conditions.
